

PROCEDURES FOR SEWER HOOKUP IN UPPER MACUNGIE TOWNSHIP

1. APPLY FOR WASTE WATER TREATMENT ALLOCATION TO LEHIGH COUNTY AUTHORITY. FORMS ARE AVAILABLE IN THE TOWNSHIP AUTHORITY OFFICE.

FOR 1 EDU, OR 223 GALLONS PER DAY, THE CHARGES ARE AS FOLLOWS:

\$1,705.95 PAYABLE TO LEHIGH COUNTY AUTHORITY (as of 7/15/2010)

\$104.72 PAYABLE TO UPPER MACUNGIE TOWNSHIP AUTHORITY

ALLOCATIONS ARE APPROVED ON THE 1ST & THE 15TH OF EVERY MONTH.

2 SEPARATE CHECKS FOR ALLOCATION, ONE TO LCA, & THE OTHER TO UMTA.

2. APPLY FOR SEWER PERMIT, SUPPLY TOWNSHIP AUTHORITY WITH NAME OF THE PLUMBER WHO WILL CONNECT THE SEWER. THE PLUMBER MUST BE LICENSED IN UPPER MACUNGIE TOWNSHIP.

FOR EACH TAP IN TO THE MAIN LINE-

\$1,100.00 TAPPIN FEE

\$50.00 INSPECTION FEE-RESIDENTIAL

\$50.00 INSPECTION FEE-DUAL

\$100.00 INSPECTION FEE-INDUSTRIAL

PLEASE DO NOT PUT THE UMTA ALLOCATION FEES ON THE SAME CHECK WITH TAPPIN & INSPECTION FEE.

3. PUMP STATION FEES
THIS FEE DEPENDS UPON LOCATION. PUMP STATION FEES ARE INCURRED WHEN THE LOCATION NEEDS A PUMP STATION TO CARRY AWAY THE SEWER DISCHARGE. THIS IS NECESSARY WHEN THE SEWER CANNOT FLOW BY GRAVITY DUE TO LACK OF ELEVATION
