01 – General Fund; 31 – Police Capital Equipment Fund

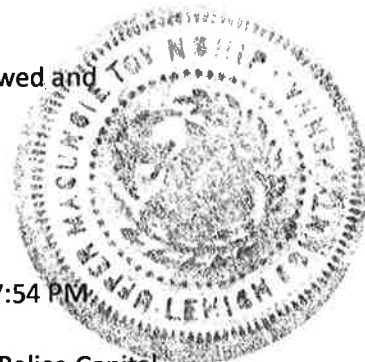
Chairman Brunell called a recess at 7:52 PM. Chairman Brunell resumed the meeting at 7:54 PM.
